All ties between myself and the "Southwark Assessment Team" were disconnected when they told me on the phone in May 2022 that they cannot give me a letter or anything in writing to establish the relationship between myself and them because I'm no longer a patient of theirs. In fact, I was never a patient according to their records. This phone call in 2022 automatically annulled the (22/09/2021) Letter from the Mental health experts. If another letter of correspondence occurs in this current year, I will need to see the police incident from which it is deriving from.

Police incident: 04/06/2023

It was Sunday; I had just come back from church; my mom was at the church I went to she can attest to this. David had come back from work, I went to the bathroom, he turned the water off, I used the hot water instead, he turned that off too. I came out of the bathroom and responded, he pulled out his camera phone, recorded me, and then called the police. The police arrived and questioned me and I reminded them of the many similar incidents that have occurred before. My evidence composed a compelling argument to the extent that I was not in the wrong, and was therefore, not under arrest.

Wrongly accused of making noise; it turned out that the noise was made before 10pm. It is only illegal if it is made after 10pm. I was fixing my drawer. All relevant evidence was presented to the police.


